In order to be enrolled in Tver State University, within the time frame established by the Admission Rules, it is necessary to:

- 01 Submit documents;**
- 02 Pass entrance tests;**
- 03 Submit the original document of education with a translation into Russian/Conclude an agreement for the provision of paid educational services;**
- 04 Pay for tuition (in case of admission on a paid basis)**




LIST OF DOCUMENTS FOR SUBMISSION IN 2025



- the application of the established form (to be filled in at the selection committee);
- a copy of the identity document, citizenship with a translation into Russian;
- the original or a photocopy of education document with a translation into Russian;
- the certificate of recognition of the education document (if necessary) – to be issued in the «National Accreditation Agency (NAA)” (Moscow);
- the original or a photocopy of the medical certificate with a translation into Russian (for the fields for which a medical examination is provided for by the legislation of the Russian Federation)
- 1 photo 3x4.

ENROLLMENT

When applying for bachelor's and specialist degree programs in full-time, in the correspondence and part-time forms of on-site training under contracts for the provision of paid educational services:

August 29 (until 12.00) – the last day of the conclusion of contracts for the provision of paid educational services.

FEATURES OF RECEPTION OF FOREIGN CITIZENS AND PERSONS WITHOUT CITIZENSHIP

- Foreign citizens and persons without citizenship have the right to receive higher education at the expense of budgetary appropriations in accordance with the international treaties of the Russian Federation, Federal laws or established by the Government of the Russian Federation quota for education of foreign citizens and stateless persons (hereinafter – the quota for education of foreign citizens), and also for the expense of individuals and legal entities in accordance with the treaties on rendering paid educational services.
- The admission to study within the quota for education of foreign citizens is carried out in accordance with the directions of the federal executive body responsible for the development of state policy and regulatory regulation in the field of higher education. Enrollment within the quota for the education of foreign citizens is made out by a separate order (orders) of the university.
- Foreign citizens who apply for training on the basis of international agreements, in addition to the documents specified in paragraph 46 of the Admission Rules, submit documents confirming their inclusion in the number of persons specified in the relevant international agreements.

- Foreign citizens and stateless persons who are compatriots living abroad (hereinafter referred to as compatriots), in addition to the documents specified in paragraph 46 of the Admission Rules, submit originals or copies of the documents provided for in Article 17 of Federal Law № 99 of May 24, 1999 «On the State Policy of the Russian Federation in relation to Compatriots Abroad».
- Compatriots are not subject to special rights for admission to bachelor's degree programs and specialty programs provided in accordance with Federal Law № 273, unless otherwise provided by an international treaty of the Russian Federation.
- When applying for bachelor's degree programs and specialty programs under contracts for the provision of paid educational services, Tver State University independently establishes a list of entrance tests for foreign citizens and stateless persons (hereinafter – the entrance tests established for foreign citizens).

- The number of entrance tests established for foreign citizens does not differ from the number of entrance tests specified in paragraphs 15-17 of the Admission Rules.
- When submitting documents, a foreign citizen or a stateless person shall submit, in accordance with subparagraph 1 of paragraph 46 of the Admission Rules, an original or a copy of the identity document, citizenship, or a document certifying the identity of a foreign citizen in the Russian Federation or the identity of a stateless person in the Russian Federation in accordance with Article 10 of Federal Law № 115 of July 25, 2002 «On the Legal Status of Foreign Citizens in the Russian Federation».
- The admission of foreign citizens and stateless persons to educational programs containing information constituting a state secret is carried out within the quota for the education of foreign citizens in compliance with the requirements provided for by the legislation of the Russian Federation on state secrets.
